



WHERE TO RESPONSIBLY RECYCLE ELECTRONICS IN THE SAN FRANCISCO BAY AREA

It is always best to reuse or upgrade your electronic devices for as long as they function properly. However, once they are broken or truly obsolete, recycling them responsibly is the safest and most sustainable way to dispose of them.

There are many electronic recycling vendors out there, but not all of them utilize responsible or sustainable recycling practices. To help you ensure that your e-waste is handled properly and safely, the Center for Environmental Health has compiled this list of responsible recycling vendors in the San Francisco Bay Area who have signed the Electronic Recycler's Pledge of True Stewardship. The Pledge was developed in 2002 by environmental organizations including the Basel Action Network (BAN), the Silicon Valley Toxics Coalition (SVTC), and other member organizations of the Computer Take Back Campaign (CTBC). Under the Pledge, these companies have promised "to provide consumers, institutions, and businesses a sustainable and socially just avenue for disposing of obsolete or broken computers and electronic equipment." Your old electronics will not be dumped in landfills, processed using prison labor, or illegally shipped overseas to be processed or thrown away in developing countries.

Only companies located in Alameda, San Francisco, San Mateo, and Santa Clara Counties are listed here. However, they can serve residents and businesses of all Bay Area counties. Most can arrange to pick up your electronics from your home or business, and several will accept electronics sent by mail where noted.

Please note that this list is only a basic guide, and the information provided below may be subject to change. For the most up-to-date and comprehensive information on each recycler and their individual services, we suggest that you contact the company directly prior to bringing in your old electronics. Most importantly, please be sure to check the official, regularly updated BAN list of responsible recyclers at <http://www.ban.org/pledge/Locations.html> to ensure that a particular recycler is still on the list.

What do they recycle?

All types of electronics, including computers, printers, copiers, TV's, fax machines, cell phones and more. There is no quantity limit.

Who can recycle?

Individuals, small or large companies, school districts, municipalities, and government agencies. Primarily serves Northern California.

Fee for non-ARF items¹?

\$0.15/lb for large amounts of electronics, excluding televisions or computer monitors. They accept personal checks from individuals; companies will be billed.

¹ Under the California Electronic Waste Recycling Act of 2003 (known as SB20), there is an Advance Recovery Fee (ARF), usually \$6-\$10, imposed on the sale of select electronic products including cathode ray tube (CRT), liquid crystal display (LCD), and plasma devices. This includes computer monitors, laptop computers, and most televisions. The fee amount on your purchase depends on the size of the product. All ARFs are collected and put into a fund to cover the sustainable recycling of electronics. This means that those of your electronics that are covered under the ARF program will be free to recycle. However, there might be marginal costs associated with the recycling of other electronics (listed as "non-ARF items" in this list). These fees will vary by recycler; please contact each directly for their individual rates.



Drop off or pick-up?

Will pick up for companies within 20 miles for a \$65 fee, and within 21-40 miles for \$95. The fee increases for any travel over 40 miles; please contact them for more information. Individuals can drop off at any time during opening hours without an appointment. They will occasionally pick up at private residences; please call for details.

Will receive electronics sent by mail.

Businesses and consumers

Fee for non-ARF items?

CDs and DVDs, laptop, cell phone, and small electronic batteries, cell phones, printer cartridges, and computer mouses are free. For all other electronics, the fee varies by type and size or weight, but generally ranges from \$0.50/lb to \$10/item. There is a \$15-30 handling fee for TV sets.

Cash, credit cards, and debit cards are accepted; no personal checks.

Drop off or pick-up?

Can arrange business, school, or local residence pick-up in the immediate Bay Area. To request a pick-up, call 1-877-918-8900 x 707 or email pick-up@greencitizen.com.

Individuals can drop off electronics at the San Francisco or Silicon Valley Recycling Centers, or selected items at any of their two Recycling Kiosks in San Mateo, or Santa Clara Counties. *Please note that only CDs, DVDs, batteries, cell phones, and print cartridges are accepted at the kiosks.*

What do they recycle?

All computer equipment and television monitors; there is no quantity limit.

Additional services:

Safe processing and recovery of materials such as photochemical waste, precious metal residue, manufacturing scrap, ashes, and glass. Please see their website for a full list of accepted materials.

Who can recycle?

Mainly serves companies, but individuals are welcome at specified



hours (see below under “Drop off or pick-up?”).
Serves all of California.

Fee for non-ARF items?

Please call to get a fee quote on specific items. Credit cards or company/corporate checks accepted. Typically, an account is set up for each customer, who is then invoiced.

Drop off or pick-up?

Will arrange pick-up for companies. There is a drop off period for individuals every Thursday, 1-4 p.m., or by appointment. Also will receive electronics by mail.

Special note: United Datatech and ECS Refining are sister companies. UDD focuses on the recovery and resale of old electronics, while ECS Refining handles the processing and recycling of any e-waste that cannot be salvaged. Their addresses, drop-off hours, and locations are the same.

What do they recycle?

All electronic items. There is no quantity limit.

Who can recycle?

Mainly serves businesses, but individuals are also welcome at specified hours (see below under “Drop off or pick-up?”) or by appointment.
Serves all of California.

Fee for non-ARF items?

Walk-in customers pay \$0.50/lb for all non-ARF e-waste. For businesses, the fee ranges from 25-35 cents/lb. Cash, credit cards or company/corporate checks accepted.

Drop off or pick-up?

Companies can either arrange for a pick-up from their offices, or call ahead for a drop-off appointment. There is a drop-off period for individuals every Thursday, 1-4 p.m.. If you cannot make these hours, please call ahead for an appointment. *Please present a valid CA driver's license at the time of drop-off and payment.* Also will receive electronics sent by mail.

What do they recycle?

All electronic items.

Additional services:

Disk drive wiping or destruction
Full teardown and destruction of sensitive customer boards and assemblies
Excess inventory re-marketing and resale services

Who can recycle?

Businesses and consumers.

Fee for non-ARF items?

Varies by item and amount, but usually averages about \$0.20/lb. Call for details.

Only company or personal checks accepted. No cash or cards.

Drop off or pick-up?

Will arrange pick-up (\$75 fee) for both businesses and individuals in the Bay Area, including Santa Clara, Santa Cruz, Monterey, San Francisco, and Contra Costa counties. Individuals can drop off recyclables during open hours, but please call ahead first. Also will receive electronics by mail.
